## Dartmoor Railways

Alison Harris left a telephone message on 20th August saying that you were on leave, but that she felt sure you would be interested in "A Summary of the Case for Reopening the Inland Railway Route between Exeter and Newton Abbot," which I had sent.

Many recipients did not acknowledge my individual letters, as is the modern experience. Some should have done, like Mel Stride and Anne Marie Morris, who had a lot to say on the subject, but had quickly made up their minds what they were going to talk about.

A warm reply from the Rail Minister made up for all those who could not be bothered to lift a pen. Since then, another railway matter has come up and no doubt you

have been informed of developments. In the case of Ashburton Station, I have to say that I am very disappointed. On 21st April, 2004, I sent Dr. Atkinson a copy of the Railway

Development Society's (now Railfuture) 300-page South West Rail Strategy, costing £16. It was deposited in your reference library. I took it that your authority would have nothing comparable from central government and that it would be a useful source of information and perhaps guidance. There is not much in the Strategy about Ashburton, but

reinstatement of the line from Buckfastleigh is mentioned; in fact, it is priced, suggesting some serious study had occurred. Copies of the relevant pages are enclosed. When considering the station site, if only your officers, as a

matter of routine, had referred to the Strategy, then I feel sure that there would have been immediate consultation with the South Devon Railway and we would be in a different position today. As it turns out, there is no harm done and it looks very much

like Ashburton Station will be revitalized for the long term good of everyone.

But, with respect, can I ask that you change your approach? In future, will you make a point of identifying a station site with an historical name, as you would any other place with a longstanding association, and will you be more alive to the possibilities for railway reconstruction?


There are railways up Snowdon and Snaefell. Would it be so bad to have ours to Princetown rebuilt?
